# Description of product:

The AMS-1234 five-finger protective gloves has a palm side made of 0.7 - 0.8 mm thick white grain goat leather (one element, fingers 2 and 3 are sewed). The back side of the index finger and the thumb are made of the same goat leather.

The glove back side is made from a dark blue cotton knitted fabric with the surface mass of  $400 \text{ g/m}^2$ .

Reinforcement at the back side edge of the fingers is made of the same goat leather. Elastic band at wrist with velcro.
